

ALEXRENEW Deduct Meter Program

Deduct Meter Program Overview

AlexRenew's deduct meter program is designed for commercial customers using water for irrigation, cooling towers, swimming pools, or other activities that do not require a sewer system or wastewater treatment services. To enroll in the program, deduct meter customers must purchase an authorized deduct meter from AlexRenew and install and maintain it on a sewer-exempt pipe. The deduct meter will then be used to measure and deduct flows that do not enter the sewer system.

No deductions will be applied for meters that are not transmitting properly. [The meters send a cellular signal to AlexRenew with the flow reading to be deducted.]

Program costs:

Enrollment Fees:

AlexRenew's deduct meter program requires a one-time \$50 new enrollment fee (per meter)

Deduct Meter Cost:

(size required is based on your water meter size and/or water flow)

- 5/8" \$349.58
- 3/4" \$352.94
- 1" \$435.26
- 1.5" \$941.20
- 2" \$1,124.90

The average life expectancy of these meters is ten years. The prices above include the meter and the transmitter (and are subject to change).

Monthly Service Charges:

- **\$10.00** deduction service fee (per deduct meter)

Monthly service charges are fixed and apply regardless off flow measured through your meter or if the meter fails to transmit properly.

Eligibility confirmation:

Rules:

- AlexRenew reserves the right to inspect deduct meters to confirm accuracy.
- No deductions will be applied to accounts that are thirty days or more delinquent.
- In addition, participants in the deduct meter program agree to all of AlexRenew's Rates, Rules and Regulations (available on <u>alexrenew.com</u>).

Additional Required Documents:

1. A schematic illustrating that the flow measured by the deduct meter does not enter the wastewater collection (sanitary sewer) system. [Hand drawn is acceptable if legible, signed, and dated.]

2. At least two photographs of the installed, and functioning, deduct meter. One photograph at a distance to show as much of the water flow before, and after, the deduct meter as possible (while still being able to see the meter and tell what it is) and one photograph up close so that the deduct meter can be read.
